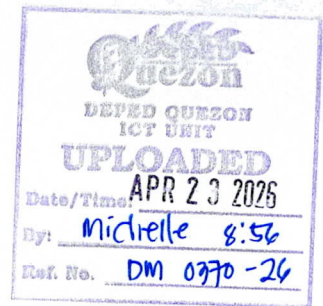

1. In accordance with Republic Act No. 11036 (National Mental Health Act), which promotes the integration of mental health services in educational institutions, and in support of the OK sa DepEd School Mental Health Program (SMHP) that strengthens school-based mental health promotion, screening, and intervention, the Schools Division Office of Quezon through the School Governance and Operations Division – School Health Section (SGOD-SHS) will conduct the **Division Training on Mental Health Assessment Using the Children and Adolescent Risk Screener (CARS) Tool on April 23, 2026 (Thursday), from 8:00 AM to 5:00 PM.** The venue of the activity shall be announced through a separate advisory.
2. The activity aims to capacitate school health and guidance personnel in the use of the Children and Adolescent Risk Screener (CARS) as a universal mental health screening tool to identify K–12 learners at risk of mental health concerns and ensure timely prevention, early intervention, and referral support. Specifically, it aims to:
 - 2.1 Understand the importance of school-based mental health assessment;
 - 2.2 Learn the structure, domains, and interpretation of the CARS Tool; and,
 - 2.4 Integrate the CARS Tool in the implementation of the School Mental Health Program at the school level.
