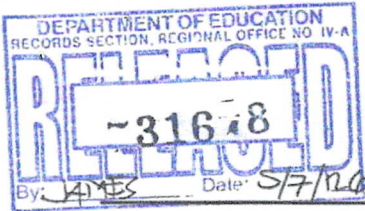



To **All Schools Division Superintendents**

1. With reference to the released RM No. 262, s. 2026, titled *Updated Official List of Final list of FY 2025 2025 National Assessment For School Heads (NASH) Batch 2 Takers and Related Personnel*, this Office, through the Human Resource Development Division (HRDD), in collaboration with the ICT Unit and the Personnel Section, releases the updated list of Assessment Site Personnel assigned to identified Assessment Sites. These personnel will serve during the **Mock and Actual Assessments on May 10 and 17, 2026, respectively**. Please see the attached enclosure for the updated list.

This Office reiterates that Assessment Site Personnel assigned to the eight (8) Assessment Sites shall be present at their respective sites on **May 9 and 16, 2026** to attend orientation and coordination meetings and to check the readiness of the sites for the Mock and Actual Assessments. Members of the Regional and SDO Technical Working Group (TWG), including the SDO NASH Focal Persons, Assessment Site Personnel, and school support staff who will render services in the Administration of NASH Batch 2, shall be entitled to vacation service credits in accordance with DepEd Order No. 013, s. 2024 "Revised Guidelines on the Grant of Vacation Service Credits for Teachers" or DepEd Order No. 009, s. 2025 "Amendment to DepEd Order No. 009, s. 2024 (Implementing Guidelines on the School Calendar and Activities for the School Year 2024-2025)," or compensatory overtime credit (COC) pursuant to CSC-DBM Joint Circular No. 2, s. 2004 "Non-Monetary Remuneration for Overtime Services Rendered," whichever is applicable.
