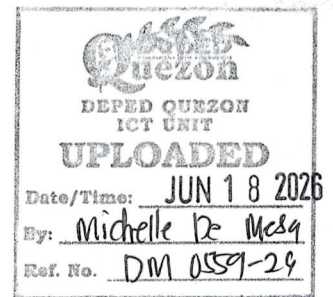

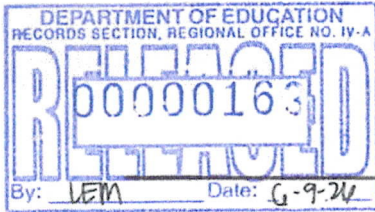

Pursuant to the DM-OUOPS-2025-10-07908¹, dated December 22, 2025, this Office, through the Education Support Services Division, announces the conduct of the Supreme Elementary Learner Government (SELG) and Supreme Secondary Learner Government (SSLG) Regional Federated Election of Officers for S.Y. 2026-2027. The RFSELG and RFSSLG elections shall be conducted on June 22 and June 23, 2026, respectively, from 8:00 AM to 3:00 PM at DepEd Region 4A Bulwagan ng Karangalan, Gate 2, Karangalan Village, Cainta, Rizal.
2. This election aims to foster leadership skills and empower learners to actively participate in school governance and highlight the significance of learner-led clubs and organizations in promoting a vibrant school culture.
