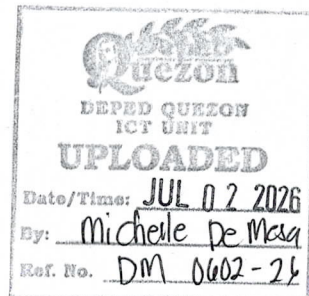

SUBJECT : **Expiry and Replacement of LANDBANK Cards**

Greetings from the Land Bank of the Philippines (LANDBANK).

We would like to inform **DepEd Quezon** that a number of **LANDBANK Cards** issued are scheduled to expire between **2027 and 2029**. These cards can **no longer be used for any transactions** once expired. To ensure uninterrupted access to funds and the continued processing of DepEd transactions, these cards need to be replaced prior to their expiration. For reference, the **expiration date is found on the face of each card**.

Affected Cards will be **converted and reissued as LANDBANK VISA PayWave or Mastercard Debit Cards**. Below is the summary of said cards, that are due to expire:

Particular	Total Number of Expiring Cards
DepEd	6

Please note that the newly issued VISA PayWave / Mastercard Debit Cards will carry the **standard LANDBANK card design** and will **no longer feature customized agency branding**. These cards will come with the following standard limits and features:

- **ATM withdrawals:** up to **₱50,000 per day**
- **Point-of-Sale (POS) transactions:** up to **₱50,000 per day**
- **Fund transfers:** up to **₱200,000 per day**
- **Access to local and international ATMs** for withdrawals, balance inquiry, fund transfers, and other applicable transactions
- **eCommerce capability** for online purchases (e.g., Lazada, Shopee, Grab, etc.)
- **Contactless payment feature** for eligible transactions (e.g., MRT-3, LRT)

**WHAT'S NEW?**

These new debit cards provide **enhanced security, wider acceptance locally and overseas, and improved access to digital and electronic banking services.**


Final card limits and features remain subject to LANDBANK policies, system configurations, and applicable regulatory requirements.


