#### VLOG-MAKING CONTEST

- 1. The activity is an individual short vlog-making contest which is open to secondary school students of DepEd Quezon.
- 2. The participants shall make a vlog incorporating the theme "Only One Earth". The setting of the vlog shall be within their residence.
- 3. The vlog entry should highlight at least one of the following environmental advocacies:
  - a. Promoting environmental education among the youth and children (e.g. responsible water/energy consumption, global challenges of climate change, responsible waste management practices); and
  - b. Personal stories of environmental conservation advocacy.
- 4. All submitted videos must be an original work and between 5-7 minutes in length, including credits. Corresponding deduction shall be made in case of excess (1-30 seconds = 1-point deduction, 31-60 seconds = 2- point deduction and so on.
- 5. The video must possess the following specifications:
  - a. The vlog should be in a landscape orientation and in the highest quality possible. (Either  $1080p [1920 \times 1080]$  or  $720p [1280 \times 720]$ ).
  - b. The content's language must be appropriate for an audience of all ages. There shall not be obscenities, misleading information and/or use of vulgar words in the content of the vlog.
  - c. When using images, sounds, or music in the entry, references of information and other related sources used in the video must be cited, crediting the original owner.
- 6. The language and dialect to be used in the vlog is either English, Tagalog or combination of both.
- 7. The video footages to be included in the vlog shall be originally recorded by the participants. Borrowing or downloading existing video is not allowed. Participants can use any cameras; be in smart phones or digital camera.

- 9. All entries will be considered property of the Schools Division of Quezon and may be used by the section for publication or any Information, Education and Communication materials.
- 10. Consistent with the provisions od Data Privacy Act and with DepEd Order No. 40, s. 2012, student-contestants must secure parents' consent, as some of the personal information of the winners will be published and posted on social media.
- 11. The Schools Division of Quezon shall not liable for any infringment of any intellectual property rights arising from the use of the entries. In case there are third-party claims of such infringement of any intellectual property rights, contestants hold DepEd free and harmless againts such claims.
- 12. Non-compliance with any of the stated contest rules and mechanics is a ground for disqualification.
- 13. The decision of the board of judges is final and irrevocable.

Relevance to the Theme	The works readily explain the theme "Only One Earth"	50%
Originality and Creativity	The work must be original and creative; the vlogger has artistically woven his/her interpretation of the given theme in the video.	35%
Technical Quality	Adherence to the technical requirements and contain creatively and correctly used elements (i.e. text, illustration etc.)	25%
Audience Impact	Measure of audience impression on the video number of Facebook Heart Reactions in their entry. Based score on the highest heart reaction.	5%
