PRE-ASSESSMENT SURVEY OF SCHOOLS AS QUARANTINE / ISOLATION FACILITY

To: Assistant Schools Division Superintendents, Division Chiefs, Education Program Supervisors, Public Schools District Supervisors, Elementary, Secondary, Senior High School Heads, District and School DRRM Coordinators, School Health Personnel and All Others Concerned


1. In reference to **OM-OSEC-2020-002**, entitled "**Guidance to Regional Directors for Action on Requests by Local Government Units to Use DepEd Schools As Quarantine or Isolation Areas for COVID-19**", the Department of Education (DepEd) has received a growing number of requests by various Local Government Units (LGUs) for the use of DepEd schools as places for quarantine or isolation as part of their response to COVID-19. DepEd is committed to render full assistance and cooperation, and to mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the COVID-19 threat, as enjoined by the President's Proclamation 922.
2. Relative to this, the School DRRM Coordinators in coordination with their School Heads and Nurses/Dentists assigned in their districts are advised to collaborate in the provision of status report of their school facilities thru answering the google link to facilitate an immediate pre-assessment of schools for ready available information once requested by the LGU for the specific intended purpose.
3. The School Health Personnel residents in each municipality together with the School Heads/District/School DRRM Coordinators are advised to assists in the pre-assessment of schools to validate the responses gathered from the google link.

5. All DepEd personnel involved in the preparation of the school premises shall strictly observe all existing health precautions and social distancing protocols of DepEd.
