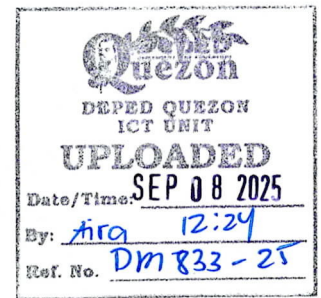

**CONDUCT OF DYNAMIC LEARNING PROGRAM ASSESSMENT TO SELECTED
SECONDARY SCHOOLS**

1. With reference to the DepEd Unnumbered Memorandum dated May 20, 2025, titled **Pilot Schools of the Dynamic Learning Program**, the Department of Education (DepEd) announces the launching of the Dynamic Learning Program Pilot (DLPP) for School Year 2025–2026 in selected secondary schools.
2. The Dynamic Learning Program (DLP) supports the Department's commitment to ensuring learning continuity during class suspensions brought about by natural calamities, disasters, and other emergencies, as well as challenges in school attendance due to congested classrooms.
3. Furthermore, an assessment to evaluate the pilot implementation of the program shall be conducted in selected secondary schools pursuant to DepEd Advisory No. 022, s. 2025, titled **Virtual Training on the Administration of the Dynamic Learning Program (DLP) Assessment for Junior High School for School Year 2025–2026**, dated July 10, 2025. The Schools Division Offices (SDOs) shall facilitate the said activity across the different regions of the country.

6. In preparation for the administration of the DLP Assessment (DLPA) and to discuss other pertinent details, an **online orientation meeting** will be conducted on **September 8, 2025**, from 1:00 p.m. to 4:00 p.m. via Zoom.
7. The online orientation meeting shall be attended by the **school heads, test administrators, support staff, and the Public Schools District Supervisors (PSDSs)** of the concerned secondary schools.
8. The Zoom meeting link will be shared through the participants' Official Facebook Messenger Group Chat.
9. Meals, transportation, and other allowable expenses incurred during the conduct of the DLPA shall be charged against the Program Support Fund (PSF) for the said activity, subject to existing accounting and auditing rules and regulations.
