The Pantawid Pamilyang Pilipino Program continues to provide holistic, integrated, and inclusive services in reducing poverty by investing in the health and education of children ages 0-18 years old. Using a standardized targeting system, which is the National Household Targeting System for Poverty Reduction (NHTS-PR) or the Listahanan, a new set of poor households will be soon registered to the Pantawid Pamilyang Pilipino Program or 4Ps. For CALABARZON, a total of 148, 174 households were identified as potential new households, under Set 12. This is distributed by province, as follows:

Laguna	9, 116
Batangas	52, 660
Rizal	21, 771
Quezon	33, 001
