 - f. Performance Rating for the last two (2) rating periods
 - g. Other pertinent documents relative to the position can be brought on the date of evaluation for appreciation of Division Selection Board. However, all activities and accomplishments already use for an earlier promotion will no longer be credited for the next promotion. Accomplishments to qualify for the credit points will be for the last three years, if not used for previous promotion.
 - Activities and accomplishments shall be properly documented approved by the immediate chief and attested by the authorized regional/division official.
- The Members of Personnel Selection Board (PSB) and Technical Working Group (TWG) shall facilitate the online ranking procedure, validation of applicants' pertinent documents, examination and interview.
- Applicants are advised to submit their scanned pertinent documents thru http://deped.in/PSDSOpenRanking upon evaluation of documents, online interview of qualified applicants will be on May 22, 2020.
