1. In accordance with RM 288, s. 2025 titled **"2025 Regional Disaster Risk Reduction and Management Olympic,"** this Office announces the participation of SDO-Quezon and its hosting of the said event. The competition will be held at the Alcala Sports Complex, Lucena City, while billeting arrangements for all participating SDOs in Region IV-A CALABARZON will be at Quezon Science High School.
2. The Quezon delegation will be represented by the Junior and Senior High School learners of Paaralang Sekundarya ng Lucban Integrated School (PSLIS). Training and assistance will be provided by the MDRRMO Lucban and BFP Lucban Fire Station, under the supervision of designated PSLIS coaches. Kindly refer to **Enclosure No. 1** for the complete list of coaches and learners participating in the 2025 Regional DRRM Olympic.
3. In line with DO 9, s. 2005 titled **"Instituting Measures to Increase Engaged Time-On-Task and Ensuring Compliance Therewith,"** this Office strictly discourages practice sessions during regular class hours. Advisers and coaches are advised to submit a training matrix to serve as the basis for the application of overtime payment, as provided under DO 26, s. 2025 **"Guidelines on the Payment of Overtime Services of Teachers."**
4. To ensure the safety and security of all delegates from the 24 SDOs of Region IV-A CALABARZON, the DRRM Unit of Quezon is hereby directed to activate the Division DRRM Response Team. The team shall implement safety protocols during the arrival of participants on October 10, 2025 at Quezon Science High School and throughout the competition proper on October 11, 2025 at Alcala Sports Complex.
