# REITERATION ON THE GUIDELINES ON THE UTILIZATION, DOCUMENTATION AND REPORTING OF DOWNLOADED FUND FOR CLEAN-UP AND MINOR REPAIRS FOR SCHOOLS AFFECTED BY STY KARDING

- In reference to OUGFO MEMORANDUM No. 2022-04-1362 or the Guidelines on the Utilization, Documentation and reporting of Downloaded Funds for Clean-up and Minor Repairs for Schools affected by STY Karding shall be utilized for, but not limited to, the following activities.
  - a. Purchase of supplies and equipment to be used for the said purposed;
  - b. Payment of labor services of Non-Deped personnel; and
  - c. Other expenses related to clean-up and minor repair of schools
- 2. For documentation and monitoring of the aforemnetioned activity, the schools are required to do the following:
  - a. Take photos before and after the clean-up and minor repair;
  - b. Consolidate and archive photos, completion reports and certification of submitted liquidation reports;
  - c. Submit in duplicate copy the accomplishment report to Division DRRM Unit copy furnish the Education Facilities Section through Engr. Ramir O. Arbolente within two weeks after receipt the downloaded fund.
- 3. All expenses shall be subject to the usual budgeting, accounting, auditing, and procurement rules and regulations. Misuse and/or mismanagement of these funds
