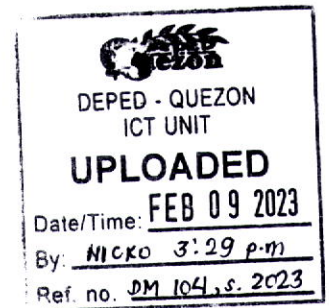

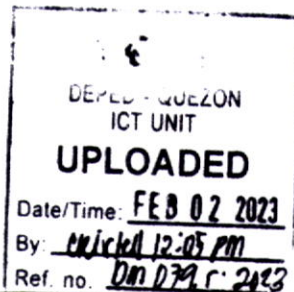

1. As promulgated in Republic Act 9155 (Governance of Basic Education Act of 2001) mandating the decentralization of school management and providing for the participation of stakeholders and local government units in addressing issues on access and quality education, as well as in the implementation of DepEd Order No. 83, s. 2012 (Implementing Guidelines on the Revised SBM Framework, Assessment Process, and Tool) highlighting school-community partnerships, **DepEd Order No. 26, s. 2022 (Implementing Guidelines on the Establishment of the School Governance Council)** was issued by the Department of Education.
2. SDO Quezon ardently supports this mandate; hence, this Office through the SGOD-SMME will conduct a technical assistance workshop on managing, documenting and assessing the SGC on **February 9-10, 2023** at a venue to be announced in a separate Memorandum.
