

PROVISION OF MULTIVITAMINS WITH ZINC, CALMOSEPTINE OINTMENT, AND HEADLICE TREATMENT SHAMPOO TO SCHOOL-BASED FEEDING PROGRAM BENEFICIARIES FOR SY 2024-2025

- 1. Relevant to the complementary activities of School-Based Feeding Program (SBFP) which includes health appraisal of SBFP beneficiaries, this Office announces the provision of the following:
 - Multivitamins with Zinc (60ml)- vitamin supplementation
 - Calmoseptine ointment- for treatment of minor cuts and scrapes, minor burns and irradiated skin, fistulas, moisture in skin folds, partialthickness wounds and,
 - Headlice shampoo for treatment and prevention of head lice and nits to School-Based Feeding Program (SBFP) beneficiaries for SY 2024-2025 through the SBFP Program Support Fund.
- 2. The said medical supplies shall be **endorsed to the assigned district nurses** who are responsible in the distribution and treatment of common ailments found during health assessment.
- All Administrative Officers II/ District Property Custodians are advised to receive
 and inspect the delivery of the said medical supplies per Drop Off Point (DOP) anytime
 in January 2025.


