

CONDUCT OF THE PALARONG QUEZON S.Y. 2025-2026

To: Assistant Schools Division Superintendents
CID and SGOD Chiefs
Education Program Supervisors
Public Schools District Supervisors
Public and Private School Heads
All Others Concerned

1. In line with the annual Division Athletic Association Meet and in preparation for the 2026 Regional Athletic Association Meet, the Schools Division Office (SDO) Quezon and the Provincial Government of Quezon shall host and conduct the **Palarong Quezon S.Y. 2025-2026** with the theme: **“Atletang Quezonian: Pinanday sa Tiyaga at Husay ng Pagsasanay, Aabutin ang Tagumpay.”** on November 22-29, 2025.
2. This activity will be supported by the municipalities of the Second Congressional District which will serve as the designated host venues for both the sports competitions and the billeting quarters.
3. The *Palarong Quezon* shall be participated in by the winning athletes and teams from the municipal level. **Submission, screening, and evaluation of athletes’ documents** shall be conducted on **November 15-18, 2025**, 8:00 AM at Sevilla’s Hotel and Resort, Brgy. Domoit, Lucena City.
4. The **Working Committee on Supplies and Equipment** will transport items from the SDO to the playing venues on **November 18-21**.
5. The **Refresher Course for Officiating Officials**, under the supervision of designated monitoring officials, will be conducted on **November 22, 2025**. All officiating officials are advised to arrive early and bring complete sets of bedding for the entire duration of the event. The Refresher Course and Solidarity Meeting for the basketball and football teams will be held in Tiaong, Quezon, and Sariaya, Quezon, respectively.
6. All tournament directors, assistant tournament directors, coaches, officiating officials, members of the Technical Working Group (TWG), and monitoring officials are enjoined to attend the **Solidarity Meeting on November 23, 2025**. The host venues for the Solidarity Meeting are as follows:

- a. **Sariaya Complex Center**– all playing venues at Quezon National High School and other sports facilities within Sariaya,
 - b. **MSEUF Candelaria** - all playing venues located in Candelaria, Quezon, and
 - c. **Tiaong Center Convention** – all playing venues located in Tiaong and San Antonio, Quezon.
7. The **Grand Opening Ceremony on November 24, 2025**, at the Quezon Convention Center in Lucena City will be attended by 40 delegates from each municipality. Highlights of the ceremony include a grand parade around the convention center, followed by a one-minute spirit cheer performance from each municipality. Simultaneously, preliminary games will be held at their respective venues.
 8. Enclosed are the indicative program of activities, designated billeting quarters, preliminary games, sports competition venues, list of officiating officials, and the composition of various working committees. The *Palarong Pambansa* Guidelines, Rules, and Procedures shall govern all sports events. Please refer to DepEd Memorandum No. 041, s. 2025 for your guidance.
 9. Schools in Sariaya, Tiaong, and Candelaria, Quezon are the designated billeting quarters of all municipalities in the First, Third, and Fourth Congressional Districts, respectively. However, municipalities in the Second Congressional District will use billeting quarters located within their respective localities.
 10. The officiating officials and TWGs will be accommodated in their assigned host municipalities, which also serve as the game venues. Additionally, Quezon National High School has been designated as the billeting site for coaches, chaperones, and student-athletes participating in the athletic sports event. All food must be completely prepared and cooked off-site before delivery.
 11. Teachers serving as members of the Technical Working Group (TWG), officials, coaches, chaperones, and trainers during the selection, screening, training, and conduct of competitions—whether at the school, district, division, or higher levels, and regardless of whether these activities fall on holidays or weekends—shall be entitled to service credits in accordance with DepEd Order No. 53, s. 2003, “*Granting of Vacation Service Credits to Teachers.*” Non-teaching and teaching-related personnel, on the other hand, shall be granted compensatory time-off (CTO) pursuant to CSC and DBM Joint Circular No. 2, s. 2004.
 12. Teachers assigned to these functions are expected to integrate support activities with the subjects they teach to ensure continued student engagement. School heads shall ensure that competent teachers are designated to handle the affected classes in compliance with the required teacher–student contact time.
 13. All activities related to the preparation and conduct of the event shall adhere to the provisions of DepEd Order No. 9, s. 2005, titled “*Instituting Measures to Increase Engaged Time-on-Task,*” and DepEd Order No. 12, s. 2025, titled “*Multi-Year Implementing*”

Guidelines on the School Calendar and Activities for the School Year 2025–2026, particularly on the prevention of class disruption.

14. All delegations shall be responsible for the protection, welfare, and safety of their learner-athletes in adherence to the provisions of DO 40, s. 2012 (DepEd Child Protection Policy) and Enclosure No. 3 (Guidelines on the Health and Safety Protocols, Learners Rights and Protection, and Disaster Risk Reduction Management. The Municipal delegation must ensure that learner-athletes are registered in Red Cross and GSP/BSP and shall provide medical insurance coverage for the athletes.
15. Expenses relative to the conduct of this activity shall be charged to Special Education Fund (SEF), while the delegation participants' expenses shall be charged against their LGU SEF, MOOE/ local funds and other sources of funds subject to usual accounting and auditing rules and regulations.
16. The technical working group and officiating officials' travel expenses and other incidental expenses, not covered by the provincial SEF, shall be charged against LGU SEF, MOOE or local funds, and other sources. The Municipal delegation shall provide food for the officiating officials during their service from November 22-29, 2025.
17. Immediate dissemination and compliance of this Memorandum is desired.
