

1. In compliance to the **Dangerous Drugs Board Regulation No. 5, s. 2007** titled **Institutionalizing the Barkada Kontra Droga (BKD) Program** and in support to the **DepEd Order No. 30, s. 2018** titled **Preventive Drug Education Program Policy for Curriculum and Instruction**, this Office, through the School Governance and Operations Division – Learner Formation Section (SGOD-LFS), announces the conduct of Alcohol Education, Tobacco Control, and Refusal Skills Training for Barkada Kontra Droga (BKD) Officers – Phase 1 on **November 23, 2025** at **M. I. Sevilla’s Resort, Brgy. Domoit, Lucena City**.
2. This phase of the said activity aims to capacitate the division officers of the Barkada Kontra Droga (BKD) on alcohol education, tobacco control, and refusal skills. Specifically, the objectives of the activity are:
 - orient the BKD officers on relevant policies and information regarding alcoholic beverages and their effects to school learners and youth;
 - discuss implementing rules and significant data on tobacco control including anti-vaping practices; and
 - conduct workshop on developing the refusal skills of school learners against harmful substances and other forms of vices.
3. All non-teaching personnel who will attend this activity shall be entitled to compensatory time-off (CTO) in accordance to **CSC and DBM Joint Circular No. 2, s. 2004**.


