1. In compliance to the **Dangerous Drugs Board Regulation No. 5, s. 2007** titled **Institutionalizing the Barkada Kontra Droga (BKD) Program** and in support to the **DepEd Order No. 30, s. 2018** titled **Preventive Drug Education Program Policy for Curriculum and Instruction**, this Office, through the School Governance and Operations Division – Learner Formation Section (SGOD-LFS), announces the conduct of Alcohol Education, Tobacco Control, and Refusal Skills Training for Barkada Kontra Droga (BKD) Officers – Phase 2 cum Division Drug Abuse Prevention and Control (DAPC) Week Celebration on **November 30, 2025**. The venue shall be announced in a separate memorandum.
