To: OIC-Assistant Schools Division Superintendents, CID Chief, SGOD Chief, Unit Heads, Accounting Staff, Public Schools District Supervisors, Public Elementary and Secondary School Heads, All Others Concerned

- 1.In preparation for the 2021 National Qualifying Examination for School Heads (NQESH) and to determine the participants of the Project PUSH (Professional Upliftment for School Heads), the following criteria will be used in accordance with DepEd Memorandum No. 158, s. 2018 subject to change upon release of the official NQESH 2021 guidelines.
 - · Experience of at least any of the following:
 - a) One (1) year as head teacher, or
 - b) Two (2) years as teacher-in-charge (TIC), or
 - c) Two (2) years as master teacher (MT), or
 - d) Five (5) years as teacher III or SPED Teacher; or
 - e) Education Program Specialist and Senior Education Program Specialist who meet the minimum Qualification Standards (QS) for Principal I position stipulated in DO 39, s. 2007 entitled Modified Qualification Standards for the Position of Head Teachers and Principals.
- For data gathering purposes, the Public Schools District Supervisor (PSDSs) and designated district Officer-in-Charge (OIC) shall facilitate the screening, evaluation, and submission of list using this template on or before March 22, 2021:
