To: Assistant Schools Division Superintendents, CID and SGOD Chiefs, Public Schools District Supervisors, Elementary and Secondary School Heads, GAD Coordinators and All Concerned

1. With reference to the **Division Memorandum No. 092, s. 2020** dated April 20, 2020 regarding the "**Online Submission of Names of District GAD Coordinators**", this Office acknowledges the designated District GAD Coordinators. Please see Enclosure No. 1.
2. Further, the **designated District GAD Coordinators** shall perform the following duties and functions as they apply based on DepEd Order No. 27, s. 2013:
 - a. serve as the GAD focal persons in the district;
 - b. lead in the gender mainstreaming in policies, plans and programs projects and activities (PPAs) and in the assessment of gender-responsiveness of systems, structures, policies, procedures and programs based on priority thrusts, needs and concerns of schools for its stakeholders, particularly students, parents, teachers and community partners;
 - c. analyze school programs and projects using the Harmonized GAD Guidelines for Programs and Projects to determine their gender sensitivity;
 - d. recommend formulation/revision of school policies in advancing women's status and child protection;
 - e. lead in the review and updating of sex-disaggregated data for school GAD database to serve as basis in performance-based gender responsive planning;
 - f. implement advocacy activities, including the development of information, education and communication materials to ensure consciousness-building and generating support for school GAD;
 - g. identify gender issues arising from gender analysis and audit to serve as basis for determining school PPAs in the GAD Plan;
