

- A technical dry run is scheduled a day before the scheduled live streaming.
 All personnel involved in the program are required to attend both the technical dry run and actual live streaming.
- 7. The RO will invite guests/resource persons from schools division offices and schools to share their expertise, best practices and experiences on the topic.
- 8. New segments of season 2 are:
 - a. 'WELLness' Physical health, mental health, disaster preparedness, first aid, etc.;
 - b. OMV "Oh My Vlog"- Students/ Teachers/ Regional Office personnel report/ update via vlogs – related to the topic theme;
 - TAL'enTO (Talent na may Kwento) weekly intermission number either musical, dance, arts, etc. featuring students, teachers, non-teaching personnel, parents /per episode;
 - d. "ABT" Audience Bubble Talk (Ano Ba Talaga?) Recorded videos of students asking questions about the topic of the week. Sample: "Ano Ba Talaga ang dapat gawin kapag sumasagot ng module?"
- The program will be broadcasted on the official Facebook pages of DepEd CALABARZON Regional Office. These are DepEd R-4A Calabarzon (https://www.facebook.com/deped.calabarzon) and DepEd Tayo Calabarzon (https://www.facebook.com/DepEdTayoCalabarzon) at 9:00 am on the target dates mentioned above.
- 10. The program will be crossposted on the Schools Division Offices' DepEd Tayo pages. In case the SDO FB page has not established a crossposting

relationship with the Region's FB page, the Division will need to coordinate with the Public Affairs Unit through pau.calabarzon@deped.gov.ph.

- 11. All designated School Information Coordinators (SICs) are advised to share the weekly live streaming of DepEd 4A For You on their official school's FB pages.
- 12. Travel expenses of the Schools Division personnel part of the production team, food, and incidental expenses for the entire DepEd 4A For You Season 2 Production shall be charged against Regional funds subject to the usual accounting and auditing rules and regulations.
- 13. Travel expenses of Schools Division Office personnel who serve as guests on DepEd 4A For You Season 2 shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
