
TEMPORARY DEFERMENT OF THE ADMINISTRATION OF SPECIAL PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT) FOR JUNE, 2020 AND UPDATED INSTRUCTION ON THE APPLICATION/ REGISTRATION FOR SPECIAL PEPT

To: CID and SGOD Chiefs, Division Testing Coordinator, Public Schools District Supervisors, Elementary and Secondary School Heads, District and School Testing Coordinators, All Others Concerned

- In reference to the Memorandum of the Undersecretary for Curriculum and Instruction number DM-CI-2020-00093 (enclosed in this memorandum), this Office informs the entire Division of the following:
  - The Special Philippine Educational Placement Test (PEPT) scheduled for June of every year is temporarily deferred until future notice from the Bureau of Education Assessment (BEA) due to COVID-19 outbreak.
  - For the mean time, applications and registrations for the Special PEPT in the Division are open/encouraged until the higher offices announced a deadline.
- As per DepEd Order No. 55, s. 2016 entitled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program, the following may register for the Special PEPT:
  - Learners from schools without government permit;
  - · Learners from nonformal and informal education programs;
  - Learners who have incomplete or no record of formal schooling;
  - · Learners with back subjects;
  - · Learners who need grade level standard assessments; and



Pursuant to Enclosure No. 2 of DepEd Order No. 007, s. 2020 entitled 'School Calendar and Activities for School Year 2020-2021', the administration of Special Philippine Educational Placement Test (PEPT) shall be within the month of June of the current year. However, in light of the COVID-19 outbreak in the country; Proclamation No. 922 otherwise known as 'Declaring a State of Public Health Emergency throughout the Philippines'; and, taking into consideration all necessary precautionary measures to ensure the health and safety of all registrants/examinees, school, division and regional testing personnel, the administration of Special PEPT nationwide is temporarily deferred until such time that specific guidelines has been crafted and issued by the Department in relation to the conduct of national assessments, taking into account serious limitations imposed by the COVID-19 pandemic.

School and division testing personnel are still encouraged to register and accept applicants for Special PEPT. Deadline of registration shall be announced in a separate Advisory. During registration, everyone is encouraged to strictly observe health and safety protocols or use online platforms as a means in submitting and evaluating documentary requirements and registering/accepting applicants.

Immediate and wide dissemination of this Memorandum is desired.
