- Relative to DepEd Memorandum No. 223, s. 2016 entitled Strengthening the Implementation of the Gulayan sa Paaralan Program (GPP) in Public Elementary and Secondary Schools Nationwide, the School Governance and Operations Division – Youth Formation Section shall provide vegetable seed packs to sustain and strengthen school-based vegetable gardens.
