1. This is pursuant to DepEd Order No. 114, s. 2017, which reiterates the reportorial obligation of public and private schools, schools division offices, and regional offices to ensure the strict implementation of the Child Protection Policy (DepEd Order No. 40, s.2012), Implementing Rules and Regulations of the Anti-Bullying Act (DepEd Order No. 55, s. 2013, RA 10627), and the DepEd Guidelines and Procedures on the Management of Children-at-Risk (CAR) and Children in Conflict with the Law (CICL) embodied in DepEd Order No. 18., s. 2015.
