- With reference to Division Memorandum No. 097, s. 2022 dated February 9, 2022, Re: Recruitment, Selection, Evaluation and Ranking of Teacher-Applicants for SY 2022-2023 (Batch 1), entries in Enclosure 1 should be corrected as follow:
 - a. Cluster of Pagbilao and Lucban on March 15-16, 2022 shall be held at Paaraalang Elementarya ng Lucban 1 (PEL 1) instead of Pagbilao Central School.
 - b. Cluster of Mauban and Sampaloc on March 17-18, 2022 shall be held at Mauban North Central School instead of Mauban South Central School.
