

In compliance with DM-OUOPS-2025-11-00442 titled Learner Government Elections for School Year (SY) 2025-2026, this Office, through the School Governance and Operations Division - Learner Formation Section (SGOD-LFS), announces the conduct of the Learner Government district level elections on February 27-28, 2025.
- 2. This activity shall amplify the voices of learners for representation and decision-making. Specifically, this activity aims to provide support to all learners to instill effective leadership which shall contribute to their holistic development.
- 3. All districts shall adhere to the guidelines and templates that will be discussed during the online orientation for the Learner Government district level election guidelines on February 25, 2025. - 4. The district LG COMEA shall submit their election report through the approved registry of elected officers during the cluster level elections.
- 5. All Public Schools District Supervisors shall monitor the conduct of district level elections. The accomplished monitoring tool (see Enclosure 1) shall be scanned into a PDF file and be submitted through email at sdo.quezon.learner.formation@gmail.com on or before March 3, 2025.
- 6. Conduct of all activities related to the Learner Government Program (LGP) shall follow the provisions in DepEd Order No. 09, s. 2005 - Instituting Measures to Increase Engaged Time-on-task and Ensuring Compliance Therewith; DepEd Order No. 03, s.


