DISTRIBUTION OF PERSONAL PROTECTIVE EQUIPMENT TO THE BENEFICIARIES OF PROJECT TULAY

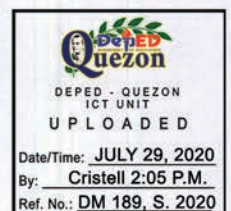
