UTILIZATION OF DEPED QUALITY POLICY STATEMENT (QPS)

To: OIC-Assistant Schools Division Superintendents, SGOD Chief, CID Chief, Education Program Supervisors and Specialists, Section Chiefs, Public Schools District Supervisors, Division Personnel, School Heads, Teaching and Non-Teaching Personnel and All Others Concerned

- 1. Pursuant to EO No. 605, s. 2007 titled Institutionalizing the Structure, Mechanisms, and Standards to Implement the Government Quality Management Program (GQMP) which directs all departments and agencies of the Executive branch to adopt a QMS as part of the implementation of a government-wide quality management program, the Department of Education issued DO 009, s. 2021 or the Institutionalization of a Quality Management System in the Department of Education.
- DO 009, s. 2021 aims to provide DepEd offices and schools/CLCs with guidelines and standards
 to integrate DepEd internal systems and processes; upgrade people capacity; ensure
 consistency in the delivery of quality services and foster continuous improvement that will result
 in enhanced and sustained client satisfaction.
- 3. Furthermore, this Order stipulates the DepEd Quality Policy Statement (QPS); to wit:

The Department of Education is committed to provide learners with quality basic education that is accessible, inclusive, and liberating through: proactive leadership, shared governance, evidence-based policies, standards, and programs, responsive and relevant curricula, highly competent and committed officials and teaching and non-teaching personnel, and an enabling learning environment.
