CREATION OF THE CHILD PROTECTION UNIT AND THE CHILD RIGHTS IN EDUCATION DESK IN THE DEPARTMENT OF EDUCATION

- The Department of Education (DepEd) issues the enclosed policy on the Creation of the Child Protection Unit (CPU) under the Office of the Undersecretary for Field Operations, Palarong Pambansa Secretariat, and DepEd Employees Associations Coordinating Office and the Child Rights in Education Desk (CREDe) under the Office of the Undersecretary for Legal Affairs in the Department.
- Pursuant to the 1987 Constitution, the State shall protect and promote the right of all children to accessible and quality basic education. Alongside this right is the constitutional policy that the State shall promote and protect their holistic development through the promotion of their physical, moral, spiritual, intellectual, and social well-being.
- The 1987 Constitution and other domestic and international laws, primarily the United Nations Convention on the Rights of the Child, guarantee a range of rights of children to promote their overall well-being. Among the rights of the child in basic education are the right to education, right against discrimination, right to health, right to participation and to have one's views heard, right to religion, right to rest and play, and right to protection against all forms of violence, abuse, neglect, cruelty, exploitation, and maltreatment.
- The Department, in upholding the right of the child to special protection and reiterating its policy of zero tolerance for any act of abuse and violence against the child, issued DepEd Order No. 40, s. 2012 titled Policy Guidelines on Protecting Children in School from Abuse, Violence, Exploitation, Discrimination, Bullying and Other Forms of Abuse, also known as the DepEd Child Protection Policy.
- The Department fully recognizes the rights of the child and takes proactive measure to uphold not only the right of the child to special protection but also the other rights of the child in the context of basic education.

- Hence, the Department created two separate but coordinating mechanisms, titled the Child Protection Unit, to strengthen the implementation of the DepEd Child Protection Policy, and the Child Rights in Education Desk, to help ensure that the rights of the child in basic education are respected, protected, promoted, and fulfilled in, and by, the Department.
- Immediate dissemination of and strict compliance with this Order is directed. 7.

RECOGNITION OF THE RED CROSS YOUTH AS OFFICIAL CO-CURRICULAR ORGANIZATION IN THE SCHOOLS

To: Regional Directors

Schools Division/City Superintendents

Heads, Public and Private Elementary and Secondary Schools

- The Red Cross Youth (RCY) is one of the six major services of the Philippine National Red Cross (PNRC). Its mission is to educate and empower the children and youth in the spirit of Red Cross through constructive trainings and effective leadership, and provide opportunities for directing and harnessing their energy and idealism into worthwhile humanitarian activities.
- The major activities of the RCY are the following:
 - Advocacy and inculcation of moral values and character building;

b. Protection of life and promotion of community health;

- Service and solidarity, which awaken in them the spirit of compassion to help people in dire need;
- National and international friendship, understanding and education for peace; and
- e. Dissemination of Red Cross Principles and International Humanitarian Law.
- Pursuant thereto, the RCY is hereby recognized as one of the official co-curricular organizations in the schools, provided that RCY activities shall observe the time-on-task policy of the Department.
- 4. Accordingly, all concerned are encouraged to assist and support the establishment of the RCY Chapters in the schools. All elementary pupils and secondary students are encouraged to enlist as members of the Junior Red Cross (JRC) and the Senior Red Cross Youth (SRCY), respectively. Likewise, the school administrator shall designate a teacher to serve as adviser of the Red Cross Youth Council.
- The Center for Students and Co-Curricular Affairs (CSCA), as the office in-charge of co-curricular matters, is tasked to coordinate and facilitate the activities of the Red Cross Youth in the Department of Education.
- 6. GUIDELINES ON REVITALIZING BOY SCOUTING IN SCHOOLS NATIONWIDE

To: Undersecretaries

- Scouting with the Boy Scouts of the Philippines (BSP) is an effective co-curricular
 program in the leadership and value formation of every child. Its main objective is
 consistent with the Department of Education's mission to develop every boy and every
 young man into well-rounded individual with exemplary character worth the emulation of
 school children. The BSP has consistently produced leaders and role models who are true
 advocates of the Scout Oath and Law.
- With its impressive track record on youth development, the Department of Education (DepEd) recognizes the significant role of the BSP in aiding the school system mold pupils and students into responsible and responsive citizens of the country and in contributing to efforts to achieve quality education. As a co-curricular program, Scouting helps stem away vices and bad influence of drugs and peers. As such, membership and participation in Boy Scouting and its programs, projects and activities should be highly encouraged and supported in the schools.
- 3. In view of this, the DepEd supports the revitalization of Boy Scouting in schools nationwide in various areas of possible partnership and cooperation. As such, DepEd is issuing the following guidelines:

3.1 Promotion of Membership to the Boy Scouts of the Philippines

All DepEd officials and personnel are encouraged to be active members of the BSP. All public and private elementary and secondary schools, through their school principals/heads, are advised to promote membership to the BSP among pupils, students, parents and teachers at the start of the School Year.

3.2 Membership Fees

Membership to the BSP is voluntary and shall not be made a condition for enrolment, transfer or clearance of pupils and students. Membership fees and proceeds of fund-raising activities of the BSP shall be immediately remitted in full to the Boy Scouts of the Philippines Local Councils duly chartered by the National Office. No quota on membership shall be required.

3.3 Schedule of Membership Campaign

July	Membership Campaign Month	
1 st Week	"Linggo ng Scouting sa Paaralan" (Introduction) Local Councils with its officials shall pay a visit to all the schools in the area. Posters m be placed in designated areas and exhibits on the incoming program projects and activities may be mounted/posted on conspicuous place to attract membership.	
2 nd Week	"Membership Campaign Period" (Orientation)	
3 rd Week	Representatives of the Boy Scouts of the Philippines may be given time during meetings of the Parents-Teachers Associations (PTAs) or any other institutional forums or meetings in the district, division or region where they can properly campaign for membership and conduct Scouting Orientation. They may also be allowed to conduct brief classroom by classroom Scouting Orientation provided that the policy on non-disruption of classes is observed.	
4 th Week	"Organization of Units" (Recruitment) The schools may organize Scout Units of Kid, Kab, Boy, Senior and Rover Scouts. The application for Unit Registration, together with the corresponding payments, is made, forwarded, remitted and receipted at the Local Council.	
August to November	Membership Registration Period The authorized membership fees are as follows: Scouts Unit Leaders Institutional Representatives/Coordinators Committee Members	

3.4 Strengthening Quality Scouting Program

Officials of the DepEd are urged to actively contribute in the development and implementation of quality scouting program by vigorously promoting and supporting the Badge or the Advancement System offered by BSP.

3.5 Participation of DepEd Officials, Personnel and School Children in Scouting Activities

All DepEd officials, personnel and school children are enjoined to participate in Scouting activities such as jamborees, camps, competitions, trainings and conferences in the school, division, regional, national and international levels, subject to existing DepEd policies, rules and regulations.

3.6 Institutional Support

All DepEd officials and personnel are encouraged to support the BSP and its activities in whatever significant way possible.

3.7 Wearing of Scout Uniforms

Wearing of the scout uniform/neckerchief by duly-registered DepEd officials and personnel, including pupils and students, during official activities of the BSP and every Friday during school days is desired for visibility and image-building.

3.8 Service Credits, Other Credits for Awards Received and Trainings Attended and Other Incentives

The following issuances are hereby reiterated:

DECS Memorandum No. 143, s. 1997 provides that service credits shall be granted for attendance in Scouting activities.

DECS Order No. 106, s. 1998 provides for the revised rules on exemption of Scouts from the Citizens Army Training (CAT).

DECS Order No. 99, s. 1999 reiterates the granting of credits to awards given by the Boy Scouts of the Philippines.

DepEd Order No. 49, s. 2007 and DepEd Order No. 92, s. 2009 provide in part that awards and citations received and training conducted and/or attended relative to Boy Scouting shall be credited and considered for employment/promotion in DepEd or in the ranking of honor pupils of students.

- 4. The Center for Students and Co-Curricular Activities (CSCA) is hereby designated as the Office-in-Charge (OIC) of all scouting matters in DepEd.
- 5. All Regional Directors, School Division/City Superintendents and School Heads/Principals shall designate a Scouting Program Coordinator in their respective regions, divisions and schools. These Coordinators shall actively facilitate the conduct of membership campaigns, as well as other activities and initiatives of the Boy Scouts of the Philippines.
- 6. All RDs, SDSs and SHs are authorized to formulate specific directives in accordance with this Order to ensure the revitalization of Boy Scouting in the schools.
- 7. The BSP, Regional and Division Offices of the DepEd shall submit all reports that may be required by the Office of the Secretary to the CSCA, DepEd Central Office.
- All other issuances not inconsistent with this Order shall remain effective.

- 1. The Department of Education (DepEd) recognizes the significant role of the Girl Scouts of the Philippines (GSP) in producing remarkable and empowered women leaders through the realization of the ideals of womanhood and preparation for their responsibilities in the home, the nation, and the world community. As a cocurricular program in the schools, Girl Scouting offers meaningful opportunities where girls can discuss contemporary issues affecting them and initiate activities that respond to these challenges. The Girl Scouting program helps contribute to the eradication of illiteracy, the achievement of quality education, and social transformation. As such, membership and participation in Girl Scouting and its programs, projects, and activities should be highly and favorably encouraged and supported in the schools.
- 2. In view of this, the DepEd promotes and espouses the revitalization of Girl Scouting in schools nationwide in various areas of potential partnership. cooperation, and collaboration.

July Membership Campaign Month

"Linggo ng Girl Scouting sa Paaralan" (Introduction)

Girl Scout councils, with its council and/or regional and/or national officials, shall First week pay a visit to all the schools in the area. Posters may be placed in designated areas and exhibits on the upcoming or continuing programs, projects, and activities may be mounted/posted in conspicuous places to attract membership.

Second "Membership Campaign Period' (Orientation) week

"Girl Scouting Orientation"

Representatives of the GSP may be given time during meetings of the Parents-Teachers Associations (PTAs) or during any other institutional forums or meetings in

Third week the district, division, or region where they can properly campaign for membership and conduct Girl Scouting orientation. They may also be allowed to conduct a brief classroom-by-classroom Girl Scouting orientation, provided that the policy on no-

disruption of classes is observed.

Organization of Units (Recruitment)

Fourth week

The schools may organize Troops of Twinkler, Star, Junior, Senior, and Cadet Girl Scouts. The Membership Registration Form, together with the corresponding payment is made, forwarded, remitted, and issued a receipt at the GS Council office.

Membership Registration Period

The authorized membership fees are as follows:

Girl Scouts (Girls) - P 50.00

August to

Adults/Troop Leaders - P 50.00

November Council Committee Member – P 50.00

Council Board Member – P 175.00 Council President – P 400.00

To revitalize Girl Scouting in all schools, the DepEd is issuing the following guidelines:

1. Promotion of Membership to the GSP

All DepEd officials and personnel are urged to be active members of the GSP.

At the beginning of the School Year (SY), all public and private elementary and secondary schools, through their school principals/heads, are advised to promote membership into the GSP among girl-pupils and girl-students, parents, and teachers.

2. Membership Fees

Membership to the GSP is voluntary and shall not be made a condition for enrolment, transfer, or clearance of pupils and students. Membership fees and proceeds of fund-raising activities of the GSP shall be immediately remitted in full to the GSP local councils duly chartered by the National Headquarters. No quota on membership shall be required.

Schedule of Membership Campaign is as follows:

4. Intensifying the Quality of the Girl Scouting Program
Officials of the DepEd are urged to actively contribute in the development
and implementation of quality Girl Scouting program by zealously and
vigorously promoting and supporting the Program of the GSP, specifically
the Eight-Point Challenge, Badgework, Chief Girl Scout Medal, Pilar
Hidalgo Lim Troop Achievement Award, Millenium Development Goals
Campaign, Stop the Violence Campaign, and the Duke of Edinburgh
Awards, among others.

5. Participation of DepEd Officials, Personnel, and School Children in Girl Scouting Activities

All DepEd officials, personnel, and school children are enjoined to participate in Girl Scouting activities such as national contests/competitions, training and conferences in the school, division, regional, national, and international levels, subject to the existing DepEd policies, rules, and regulations.

6. Institutional Support

All DepEd officials and personnel are encouraged to support the GSP and its activities in all or whatever significant way possible.

7. Wearing of the Girl Scout Uniform

The wearing of the Girl Scout Official Business Uniform by duly-registered DepEd officials and personnel, including pupils and students, during official GSP activities and every Friday during school days is highly desired for visibility and positive image-building.

8. Service Credits, Other Credits for Awards Received and Training Sessions Attended, and Other Incentives

The following issuances are hereby reiterated:

- i. DECS Memorandum No. 143, s. 1997 provides that service credit shall be granted for attendance in Girl Scouting activities.
- ii. DECS Order No. 106, s. 1998 provides for the revised rules on exemption of Girl Scouts from the Citizen's Army Training (CAT); and
- ii. DECS Order No. 49, s. 2007 and DepEd Order No. 92, s. 2009
 provide in part that awards and citations received and training
 conducted and/or attended relative to Girl Scouting shall be
 credited and considered for employment/promotion in DepEd or in
 ranking of honor pupils or students.

 All Girl Scouting matters in the DepEd shall be handled by the Center for Students and Co-Curricular Affairs (CSCA).

- All regional directors (RDs), schools division/city superintendents (SDSs), and school heads (SHs)/principals shall designate a Girl Scouting Program Coordinator in their respective regions, and schools. These Coordinators shall actively facilitate the conduct of membership campaigns, as well as other activities and initiatives of the GSP.
- All RDs, SDSs, and SHs are authorized to formulate specific directives in accordance with this Order to ensure and guarantee the revitalization of Girl Scouting in schools nationwide.
- The GSP, regional and division offices of the DepEd shall submit all reports that
 may be required by the Office of the Secretary to the CSCA, DepEd Central
 Office, DepEd Complex, Meralco Avenue, Pasig City.
- 8. All other issuances not inconsistent with this Order shall remain effective.
