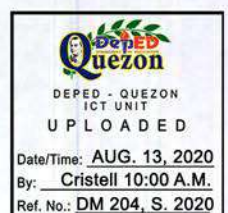
DIVISION MEMORANDUM

Monitoring of the Promotion of DepEd Core Values through the Official Supreme Pupil and Supreme Student Government Facebook Pages

To: OIC - Assistant Schools Division Superintendents, SGOD and CID Chiefs, Public Schools District Supervisors, Public Elementary and Secondary School Heads, District Youth Formation Coordinators, SPG and SSG Advisers and All Others Concerned

1. As per **Regional Memorandum No. 282**, the Schools Division of Quezon Province through the School Governance and Operations Division – Youth Formation and Development Section shall maximize the use of social media through the Official Facebook Pages of the Supreme Pupil Government (SPG) and Supreme Student Government (SSG) in promoting the four core values of DepEd: **Maka-Diyos, Makakalikasan, Makatao, Makabansa** to all learners.
2. SPG Advisers are tasked to collaborate in creating their respective **Official District SPG Facebook Page** in posting online programs and activities anchored with the DepEd Core Values of all elementary schools.

4. All page administrators are encouraged to publish post anchored with the DepEd Core Values and compliant to the Data Privacy Act of 2012 and Child Protection Policy.
5. SPG and SSG logos of the school/district shall be used as profile picture of the page.
6. All posts in the District Facebook Page of SPG and School Facebook Page of SSG shall be monitored by the assigned Project Development Officers per Congressional District. It will be covered for 15 days or twice a month.
