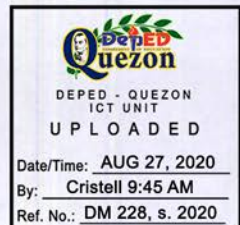

Mobile Photography Competition Mechanics

1. This category shall be open to all bonafide pupils and students in DepEd – Division of Quezon.
2. Official entries shall be sent to yfdquezon@gmail.com with a file name PHOTO/Surname/School. (e.g. PHOTO/DelaCruz/QuezonNHS)
3. A qualified entry shall comprise the following:
 - a. An original set of photos (minimum of 5 and a maximum of 8, taken by mobile phone camera) showing Quezonian families at home coping with the “New Normal” as one of the major changes brought by the COVID-19 pandemic.
 - b. A appropriate title either in English or Filipino must be included to summarize the story or message of the photos.
 - c. No more captions needed for each of the chosen photos.
 - d. The final layout must be in PDF (9” by 12”) in portrait. (See attached template)
 - e. All photos must be taken inside the house. Photos captured outside shall be a ground for disqualification.
4. Deadline of submission of entries is on the indicated date and time of the contest matrix.
5. All entries for this competition shall be judged according to the following criteria:
 - a. Effectiveness of the Photos (40%)
 - Photos must be able to portray and/or encourage the Quezonian spirit towards discipline, hardwork, sacrifice, consideration for others, faith and strong family ties.
 - b. Overall Quality (30%)
 - This involves various techniques and styles that a participant will be able to apply to the photos.
 - c. Uniqueness and Impact (30%)
 - It must show how a participant can think “out of the box” and finish with an output that is original but can still clearly convey the theme.
6. Judges' decision shall be final and irrevocable.

Vlogging Competition Mechanics

1. The contest is open for secondary students of DepEd Quezon.
2. The contest can be participated by solo or family member.
3. The participant/s shall make a vlog incorporating the theme #ChallengeAccepted: Transforming Lives of the Youth with New Normal. The settling of the vlog shall be within the house showing any of the Deped 4 core values.
4. Vlog entries shall be 3-5 minutes long (including the credits). Corresponding deduction shall be made in case of excess (1-30 seconds, 1 point deduction, 31-60 seconds, 2- point deduction and so on and so forth).
5. The language and dialect to be used in the vlog is either English, Tagalog or combination of both.
6. There shall be no obscenities and/ or use of vulgar words in the content of the vlog.
7. The video footages to be included in the vlog shall be originally recorded by the participant/s. Borrowing or downloading existing video is not allowed. Participant/s can use any cameras- be in smart phones or digital camera.
8. The Vlog Entries shall be in MP4 format and shall be sent to yfdquezon@gmail.com on the indicated date and time of the contest matrix with the subject (VLOG COMPETITION) name of the student, school and grade level.

The criteria for judging are as follows:

Content - this includes the speaking line of the participant/s as well as the things happening or featured in the vlog	40%
Creativity - this includes the overall concept and story line 30 %	30%
Editing -this includes how the video was edited sequencing, background music and sounds effects-20%	20%
Overall Impact -This Includes the total number of Facebook Reactions in their-entry-10%	10%
Total	100%

4. The following materials will be used in the contest:
 - A. A ¼ illustration board (white background & vertical format) and a Mongol pencil (to be provided by the contestant)
 - B. Coloring material: oil pastel/craypas, markers, ink, mixed media, oil, acrylic and watercolor (to be provided by the contestant) *Use of other materials not specified above is strictly prohibited.
5. Posters must be done in free hand.
6. Scanned copy of the entries must be submitted on the indicated date and time of the contest matrix at yfdquezon@gmail.com with the subject (*Title of the Poster* - POSTER MAKING CONTEST) and the name of the artist, school, and grade level.
7. The artist will be held accountable to any issues that may arise with regards to the originality and authenticity of the design.

CRITERIA FOR JUDGING

- Creativity and Presentation (40%)
 - Originality (30%)
 - Relevance to the Theme (30%)

b. Pronunciation (Clarity)	30%
c. Timing	10%
d. Mastery of Lyrics	10%
e. Overall Impact	10%
