- Furthermore, the school heads are advised to coordinate with the Register of Deeds to comply with the requirements for titling and determine the cost for the transfer of title.
- 4. With respect to the cost of land survey, kindly coordinate with the Department of Environment and Natural Resources – Community Environment and Natural Resources Office (DENR CENRO) to find out the requirements and the cost for the conduct of survey of the school site concerned. If DENR-CENRO cannot conduct the survey, the school heads are advised to inquire with a geodetic engineer on the estimated amount of survey.
- 5. Deadline of submission for the release of fund shall be on or before May 11, 2021.
- 6. Immediate compliance to this Memorandum is desired.
