
APPLICATION FOR DIGITAL CERTIFICATE

- To: OIC-Assistant Schools Division Superintendent, Chief on School Governance and Operation, Chief on Curriculum and Implementation, Section Heads, Education Program Supervisors, Education Program Specialist, Public School District Supervisors and all others Concerned
 - This office encourage the Division Employees in applying their Digital Certificate in response to Quezon Online Document Tracking System Version 2 (QODTS) and to lessen the face to face transaction in this pandemic situation.
 - 2. Here are the following ORIGINAL scanned requirements to be submitted :
 - a. Dully accomplished form (Philippine National PKI) you may download the form thru this link: http://bit.ly/PNPKIApplicationForm
 - b. Birth Certificate in the absence of a Birth Certificate, the applicant may submit his/her passport
 - c. UMID ID in the absence of UMID ID, the applicant may submit his/her any two valid id's (company ID, driver's license, philhealth ID, TIN ID)

 - 4. All application and documents received by the Department of Information Comunications and Technology (DICT) is stricly be kept confidential and solely intended for the application of PNPKI Digital Certificate. As soon as the DICT receives the intention for applying the Digital Certificate they will schedule a video conference as verification of the applicant.
 - 5. The applicant must inform the Division Information Technology Officer (DITO) and the Records Officer once approved.
 - 6. Immediate and wide dissemination of this Memorandum is desired.

Greetings from the Department of Information and Communications Technology (DICT)!

Presidential Proclamation No. 922 placed the country under public health emergency and the whole Luzon in Enhanced Community Quarantine (ECQ) necessitate the government to implement different working schemes to ensure that vital services are still delivered to the public. Teleconferencing, Alternate Working Schedule, Skeletal Force and even Work From Home (WFH) are encouraged and implemented to ensure social distancing and that no physical contact among and between employees and the public is enforced.

In line with the above, DICT made available the Philippine National Public Key Infrastructure (PNPKI) or more popularly known as Digital Signature to critical government employees needing to sign official documents and correspondence while on WFH and/or physically away from the office.
