

- 4. The Public Schools District Supervisors (PSDSs) of the JDVP recipient senior high schools are expected to monitor and evaluate the conduct of JDVP using the prescribed tool (Annex 11) in their respective school district.

Tupas, Education Program Specialist II at (042) 784-0366 local 115.
- 6. The School Head and the JDVP Focal Person of recipient schools are expected to be present at the training venue/school during the M&E.
- Attached is Annex 11 or the JDVP Monitoring and Evaluation Tool for S.Y. 2022-2023. The hard copies of this tool shall be submitted by the encoder/PSDSs to the SGOD-SMME on or before July 6, 2023 in a long brown envelope labeled: 2023 JDVP M&E – Mulanay I/DMET Team 1.
- 8. Strict adherence to the IATF Protocols and Office Health Standards must be observed in the conduct of the activity.
