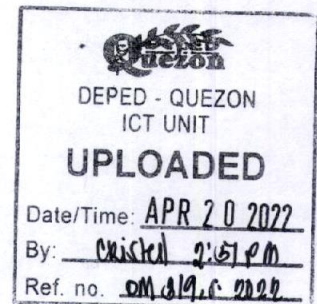

**WEBINAR ON LEARNERS' WELFARE AND PROTECTION**

**To: OIC- Assistant Schools Division Superintendents, CID and SGOD Chief, Education Program Supervisors, Public Schools District Supervisors, Secondary and Elementary Schools Heads, GAD Coordinators, Guidance Counselors, Youth Formation Section and All Concerned**

1. The Department of Education (DepEd) seeks to preserve and promote every Filipino's right to a high-quality, equitable, culturally relevant, and comprehensive basic education in a child-friendly, gender-sensitive, safe, and inspiring environment.
2. As a result, administrators, employees and teachers as learning facilitators, should be well-versed in the policies in place to safeguard the learners' welfare. They should also be well-prepared to deal with situations of child abuse and bullying by implementing appropriate preventive, protective, and corrective measures.
3. In this regard, the Legal Unit will provide a Webinar on Learners' Welfare and Protection, with the goal of educating participants on current policies on Child Protection and Anti-Bullying, as well as on the Positive Discipline in Everyday Teaching.

This will be participated by the **Public Schools District Supervisors (PSDSs), GAD Coordinators, Guidance Counselors, Select School Heads and Teachers**.
