

- 4. Other details stipulated in the previous Memorandum shall remain in effect.



## Guidelines on the Submission of Accomplishment Report and Selection for the Recognition of School Implementers with Best Practices on School-Based Feeding Program for SY 2023-2024

#### Presentation of the SBFP status of implementation:

- The Districts shall encapsulate their implementation in a 5-10 minute video presentation, showcasing the progress of implementation and best practices. Presentation shall follow the data on SBFP forms, Nutritional Status report, Program Terminal Report, Attendance and Academic Performance, and other complementary activities.
- 2. Presentation shall be sent via <a href="mailto:sdo.quezon.sbfp@deped.gov.ph">sdo.quezon.sbfp@deped.gov.ph</a> on or before April 18, 2024.
- 3. The Division SBFP TWG shall select four presenters for the presentation of accomplishments.
- 4. A special award shall be given to the District with Best Presentation on SBFP implementation.

#### Recognition of School Implementers with Best Practices:

- 1. The District shall select among school implementers one entry for the Division Search for the Outstanding School Implementer with Best Practices for SY 2023-2024.
- 2. Submission of electronic entry shall be on April 18, 2024, until 5:00 p.m. via <a href="mailto:sdo.quezon.sbfp@deped.gov.ph">sdo.quezon.sbfp@deped.gov.ph</a> following the documentary requirements and criteria as stipulated in Enclosure No. 2 of DM 295, s. 2024.
- 3. Screening and shortlisting shall be conducted by the SBFP Division Technical Working Group. Finalists shall be notified to prepare and submit an abridged version of SBFP accomplishment for poster presentation using the STAR Approach to be displayed during the Program Implementation Review.
- 4. Four winners shall be awarded as Outstanding School Implementer with Best Practices for SY 2023-2024 based on ranking results.
