General Guidelines:

- 1. The Search is open to all public and private schools in DepEd Quezon.
- 2. The Search shall be divided into two categories: elementary and secondary.
- All documentations (PDF) of BIDA Kid Campaign shall be submitted to the Division Office for shortlisting via Google Form: tinyurl.com/QuezonSearchBIDAkid. Refer to DM 027, s. 2022 for the recommended activities. Photo-documentations must have captions.
- A Memorandum for the submission of videos (mp4) of the Search qualifiers will be issued separately after the pre-evaluation.
- 5. The decision of the Division Evaluation Committee is final and irrevocable.
- 6. Interested schools may submit entries on or before May 13, 2022.
- 7. Top 10 BIDA Kid Schools will be selected from each category.
- Winning entries will be announced through a Division Memorandum, and will be posted in the DepEd Quezon website.
- Exemplary video entries will be featured in the Division's Best BIDA Kid School Awarding in DepEd Tayo Quezon and Quezon PREFIC FB Page.
