INTENSIFYING COMMUNITY AWARENESS THROUGH RECREATIONAL ENGAGEMENT (I CARE): A SPOKEN POETRY COMPETITION ON SUBSTANCE USE PREVENTION

- 1. In reference to DepEd Memorandum No. 025, s. 2021 titled Preventive Drug Education Program Curriculum Model, the BKD as the implementing and advocacy group among learners, managed and supervised by the School Governance and Operations Division Youth Formation Section (SGOD-YFS), will conduct a spoken poetry competition on substance abuse prevention for secondary learners on May 17 June 10, 2023.
- 2. It aims to demonstrate strong sense of community awareness and social responsibility among secondary learners on laws, programs, policies, and activities in connection with substance use prevention through a five-minute spoken poetry.
- 3. This competition shall follow the schedules indicated below:
 - Submission of Poetry Pieces (Online on May 17-31, 2023)
 - Screening of Poetry Pieces (June 1-2, 2023)
 - Announcement of Top Five (5) Finalists (June 3, 2023)
 - Division Level Final Competition (June 10, 2023 at SDO Training Center)
- 4. Soft copies of the poetry piece, scanned copy of the certificate of originality (Enclosure 2), and Parental Consent Form (Enclosure 3) shall be submitted in A4 size PDF format

Competition Mechanics

- Spoken poetry is a written poetry that is meant to be spoken or delivered with emotions
 to an audience. It is an oral performance that focuses on the art of word play, rhythm,
 improvisation, and intonation.
- 2. The competition is open to all public Junior High School (JHS) and Senior High School (SHS) learners (Grades 7-12) in the Division of Quezon.
- 3. The spoken poetry piece must be an original composition. It shall be written in Filipino language only (except for the scientific/medical terms). No distinguising mark or name of school or learner shall appear in the document submitted.
- 4. The piece must contain relevant information, insights, and recommendations on the following:
 - a. Substance use in the Philippines
 - b. Harmful effects of substance use on the individual, family, school, and community
 - c. Prevention and control of substance use
 - d. Current policies and laws governing substance use
 - e. Substance use prevention programs and initiatives
 - f. Developing assertiveness skills for healthy and drug-free life

It must not contain any malicious and offensive content. Violation to this rule shall be a ground for disqualification.

- 5. Only the top five (5) entries shall participate to the Division Finals on June 10, 2023 at the SDO Training Center, Pagbilao, Quezon and shall be accompanied by the school Barkada Kontra Droga (BKD) adviser.
- 6. Each finalist is given five minutes to recite or deliver his/her piece. Every one-minute excess shall correspond to a point deduction.
- Sounds, instrumental or music background is allowed to complement the delivery. No deduction shall be made if the finalist opts not to have a musical background.
- 8. Poetry pieces of the finalists shall be the property of the Division Office.
- 9. Judges' decision is final and irrevocable.

Criteria for Screening:

Content – 40%
Creativity and style – 30%
Clarity and organization – 30%

Total – 100%

Criteria for Judging:

Message/Content (50%)

- 1. The content of the spoken poetry is relevant and insightful.
- 2. The piece has a powerful and meaningful message to the audience.

Delivery and Performance (40%)

- 1. The spoken poetry is delivered with strong conviction and emotion.
- Connection to the audience was established from the start.
- Facial expression, hand, and body gestures emphasized the different elements of the performance.
- 4. Eye contact pulled the audience to the message of the spoken words.
- 5. Enunciation is clear. Words are pronounced distinctly and correctly.

Overall Impact (10%)

- The learner's physical presence, voice and articulation, dramatic appropriateness, and evidence of understanding all seem on target and unified to breathe life into the piece.
- 2. The learner brings the audience to a better understanding of the concepts through the poetry piece.
