#### CANCELLATION/ SUSPENSION OF CLASSES AND WORK DUE TO TYPHOON "ULYSSES"

To: OIC-Assistant Schools Division Superintendents, CID and SGOD Chiefs, Education Program Supervisors and Specialists, Unit/Section Heads, All SDO Personnel, Public Schools District Supervisors, Elementary and Secondary School Heads/TICs/OICs, and All Others Concerned

- 1. In view of the continuing inclement weather brought by Typhoon Ulysses with Signal No. 3 (as per DOST-PAGASA weather bulletin), and pursuant to DepEd Order No. 43 s. 2012, Guidelines on the Implementation of Executive Order No. 66 (Prescribing Rules on the Cancellation or Suspension of Classes and Work in Government Offices, Due to Typhoon), public and private preschool, kindergarten, elementary and secondary classes and work in Division Office are automatically cancelled/suspended tomorrow, November 12, 2020.
- Also, this Office would like to reiterate and remind the school heads in DepEd Order No. 43 s. 2012 on automatic cancellation/ suspension of classes and work in government offices when signal number was raised by PAGASA in certain/affected areas.
- 3. All SDO personnel are requested to stay at home and open the channel of communications in this time of need. The utmost priority of this Office is the safety of everyone during this time of typhoon/ calamities.
- 4. However, the personnel and unit directly involve in Division Disaster Risk and Reduction Management (DRRM) shall maintain their operations to monitor the situations of schools and ensure continuity of public service.
