CALL FOR AN ONLINE SUBMISSION OF COMPLETED RESEARCH FOR ORAL AND POSTER PRESENTATION IN THE 2025 QUEZON EDUCATORS' RESEARCH CONVENTION (QERC)

- 1. In reference to Provincial School Board Resolution No. 12 2024, titled "A Resolution Approving Special Education Fund Annual Budget, Fiscal Year 2025, for Priority Education Projects of the Provincial School Board," and in preparation for the upcoming Quezon Educators' Research Convention (QERC), this Office, through the School Governance and Operations Division (SGOD), invites all research enthusiasts of DepEd Quezon to submit their completed research for review and selection by the Schools Division Research Committee (SDRC).
- 2. Eligible submissions include completed action research and basic research that have undergone prior evaluation by a panel of reviewers in a research plenum or conference organized at the district, division, regional, national, or international level. Only research meeting this qualification will be considered for poster/oral presentation.
- 3. Interested researchers are expected to submit an **abridged version** of their papers with the following parts:
 - a. **Title of the Research**, along with the Name/s of Researcher/s and their School/District/Office

- b. Rationale and Research Problem (clearly define the issue/problem/gap; ensure alignment with the Five-Point Agenda, Basic Education Research Agenda, and/or Division Priority Areas)
- c. **Research Methodology** (highlight participants/data sources, data gathering tools, and data analysis techniques)
- d. **Research Intervention** (for action research only) (describe procedures for implementation or experimentation)
- e. Summary of Findings and Conclusions
- f. Recommendations and Reflections
- g. References
- 4. Submissions must include the following required documents:
 - a. The **completed research** in PDF format, following the prescribed structure above (maximum of four pages)
 - b. Signed Declaration of Anti-Plagiarism and Absence of Conflict of Interest, using the template available at: [tinyurl.com/Anti-plag-Abs-confQuezon]
 - c. Certificate of Presentation or Recognition from the research conference or plenum where the study was previously presented (PDF/scanned copy)

Formatting Guidelines:

Font: Bookman Old Style, Size 11

Spacing: Single-spaced

Margins: 1 inch on all sides

Alignment: Justified

5. The Schools Division Research Committee (SDRC) will review all compliant submissions and issue a separate memorandum indicating the list of accepted research entries, along with the submission schedule for corresponding posters and PowerPoint presentations. All presentation materials shall undergo quality assurance by the Committee prior to the final oral/poster presentation, with technical assistance









provided as necessary. Additional instructions and reminders will be communicated in a follow-up memorandum prior to the QERC event.

- 6. Submissions that fail to meet the specified requirements and formatting guidelines will be **disqualified** from review and excluded from the list of presenters.
- Researchers whose studies are successfully presented during the convention will be awarded a **Certificate of Recognition**, signed by the Schools Division Superintendent.
- 8. Completed research must be submitted **online** to the Planning and Research (PAR) Section SGOD on or before **May 26, 2025**, through the following link: tinyurl.com/2025QERCpresentSubmit.
- 9. In adherence to DepEd Memorandum DM-OSEC-OUHROD-OPS-2025-0001 concerning the 30-day undisturbed vacation, it is emphasized that submission activities coinciding with teachers' vacation are considered personal and professional development opportunities for researchers. As such, service credits will not be granted for the submission of research. However, service credits may be awarded to research presenters for the actual presentation day, provided it falls on a Saturday or Sunday, in accordance with applicable DepEd guidelines.
