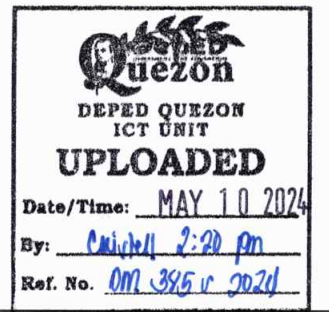

1. In reference to DepEd Order No. 59, s. 2017, titled "Adoption of New School Forms for Kindergarten, Senior High School, **Alternative Learning System**, Health and Nutrition and Standardization of Permanent Records", this Office through the Curriculum Implementation Division will conduct checking ALS permanent record for the passers of School Year 2023-2024.
