PLAN ADJUSTMENT ON SCHOOL ANNUAL IMPLEMENTATION PLAN (AIP) AND WORK AND FINANCIAL PLAN (WFP)

To: Assistant Schools Division Superintendents

School Head-in-Charge of Governance and Operations
Elementary and Secondary School Heads
All Others Concerned

- 1. In connection with the implementation of DepEd Order No. 44, s. 2015 as emanated from the Governance of Basic Education Act of 2001 (RA 9155), which empowers the school heads the authority, accountability, and responsibility to develop school education programs and the School Improvement Plan (SIP), School Heads are advised to evaluate their SIP-based Annual Implementation Plan (AIP) and Work and Financial Plan (WFP) and if necessary adjust them based on what is best for the learners they serve as reflected in the SIP.
- Plan Adjustment is an output of quarterly School Monitoring and Evaluation Plan Adjustment (SMEPA)/Program Implementation Review (PIR). Thus, only those schools who have conducted SMEPA/PIR are allowed to adjust their AIP/WFP. Moreover, the adjusted plans must also be alligned to the school's current SIP.
- 3. For the AIP/WFP to be approved, the schools are advised to submit the following documents:
 - a. Letter Request addressed to the SDS
 - b. Duly accomplished Document Adjustment Form
 - c. Copy of the old AIP (1 copy, parts adjusted are highlighted)
 - d. Copy of the ADJUSTED AIP (2 copies Accounting and School Copies)
 - e. Copy of the old WFP(1 copy, parts adjusted are highlighted)
 - f. Copy of the ADJUSTED WFP (2 copies Accounting and School Copies)
