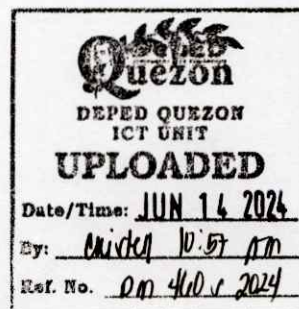

In reference to **DepEd Order No. 48, s. 2016** or the **Policy and Guidelines on Comprehensive Tobacco Control** and the observance of **National No Smoking Month** with the theme, "**Protecting Children from Tobacco Industry Interference**", this office will conduct an online survey regarding Tobacco use and exposure among SDO Quezon personnel in observance of National No Smoking Month this June, 2024.
