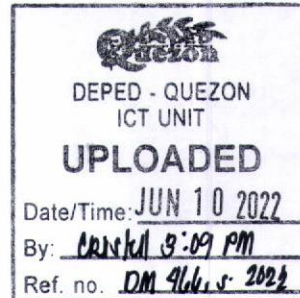

REAPPOINTMENT/RENEWAL OF SHS PROVISIONAL TEACHERS

TO: Assistant Schools Division Superintendents
Public Schools District Supervisors
Elementary, JHS and SHS Heads
SHS Provisional Teachers
All Other Concerned

1. In reference to **DepEd Order No. 34, s. 2021, Guidelines on the Implementation of CSC Resolution No. 2100451 on the Reappointment (Renewal) of Provisional Appointment of Senior High School Teachers First Hired in School Year 2016-2017 and Amendment to DepEd Order No. 51, s. 2017 dated August 25, 2021, Item No. 14**, which states that **"the validity of the appointment of the affected SHS provisional teachers first hired in SY 2016-2017 shall only be effective until the last day of SY 2021-2022."** this office would like to inform the school heads of the affected Provisional Teachers that the validity of their appointment shall only be effective until **June 24, 2022** and shall no longer be eligible for reappointment or renewal this coming SY 2022-2023.
2. Furthermore, affected provisional teachers hired in SY 2017-2018 will be effective until the end of SY 2021-2022, after which they will no longer be eligible for reappointment or renewal in SY 2022-2023, unless new issuance is issued.
3. In addition, those Provisional teachers who were first hired in SY 2018-2019, SY 2019-2020, SY 2020-2021 and SY 2021-2022, are requested to submit the necessary documents for the reappointment/renewal of their appointment **on or before June 17, 2022**; failure to do so will result in automatic **laid off from the service**.
