PILOT IMPLEMENTATION OF THE CSE-ARH CONVERGENCE IN DEPED QUEZON

- 1. In reference to the Joint Memorandum No. 003, s. 2021 on the **CSE-ARH Convergence Pilot Implementation** issued by the Department of Education (DepEd) Bureau of
 Learning Support Services (BLSS) and the Bureau of Curriculum Development (BCD),
 DepEd, in collaboration with the Department of Health (DOH) and Commission on
 Population and Development (POPCOM), has formally launched on September 2021
 the **CSE-ARH Convergence** under the OK sa DepEd ARH flagship program.
- Likewise, USAID's ReachHealth Project supports eight pilot regions, covering 14 sites
 with 45 pilot schools and their counterpart referral facilities as convergence is realized
 at the local level.
- 3. The CSE-ARH Convergence is a flagship program intervention on adolescent health that utilizes a whole government approach for resource sharing, and program complementation in addressing the prevention of unplanned teenage pregnancy in the Philippines, among relevant key government agencies, CSOs, and development partners across different levels at the national, regional, and local government unit.
