




- 6. There shall be a minimum of three and maximum of five OBE members per school, depending on the school population. The OBE members in schools must have proper knowledge on the correct enrollment process and other relevant school information.
- 7. The conduct of the OBE shall adhere to existing relevant policies of DepEd in conducting activity inside the school premises.
- 8. Non-teaching personnel shall be granted Compensatory Time-Off (CTO) for all services rendered during weekends as members of the OBE working committees and / or voluntary services in the OBE activities. Eight hours of accumulated services are equivalent to one-day CTO.
- 9. All expenses incurred related to the conduct of the OBE shall be charged to the usual accounting and auditing rules and regulations.
- 10. Immediate dissemination of this Memorandum is desired.
