



ADOPTION OF CLUSTER-BASED PROCUREMENT FOR THE 2025 IMPLEMENTATION OF THE SCHOOL-BASED FEEDING PROGRAM (SBFP)

- Pursuant to Item 2, Section VIII of DepEd Order No. 031, s. 2021, entitled Operational Guidelines on the Implementation of the School-Based Feeding Program (SBFP), a cluster of schools or a school district may elect a lead school as the procuring entity, wherein the lead school undertakes the procurement of food items while deliveries may be made directly to recipient schools. Decisions relating to procurement must be made through consensus among the clustered schools or districts to promote transparency and accountability.
- 2. In this regard, the Schools Division Office of Quezon adopts this provision in Item 2, Section VIII of DepEd Order No. 031 s. 2021 as its procurement strategy for the 2025 implementation of the SBFP. The following guidelines shall apply:
 - a. Identified Lead Schools as listed in the attached enclosure are hereby designated as the procuring entities for their respective school clusters.
 - b. The School Principal of each lead school shall serve as the Head of the Procuring Entity (HOPE) and shall ensure full compliance with the Government Procurement Reform Act (RA 9184) and other relevant DepEd guidelines.
 - c. Principals or School Heads from the clustered schools shall comprise the Bids and Awards Committee (BAC), Technical Working Group (TWG), and BAC Secretariat. HOPE must ensure that the appointed members must possess the competence and integrity required for their roles.





- d. Each designated lead school shall issue a Memorandum on the composition of the Bids and Awards Committee (BAC), the Technical Working Group (TWG), and the BAC Secretariat.
- e. A copy of the said Memorandum, duly signed by the lead school head, must be submitted to the Office of the Schools Division Superintendent on or before **June 23, 2025.**
- f. Each lead school must have an active and duly registered PHILGEPS account as part of its mandatory requirements in undertaking procurement activities.
- 3. Attached herewith is the official list of clustered schools and their corresponding designated lead schools for reference and guidance.
