


CONCEPT NOTE

BACKGROUND

Proclamation No. 361, declaring the third week of July as the National Disability Prevention and Rehabilitation Week which shall culminate on the birthdate of the sublime paralytic: Apolinario Mabini on July 23 each year. For this year, the 43rd National Disability Prevention and Rehabilitation Week Celebration will be celebrated on 17 to 23 of July 2021.

Pursuant to Article 28 of the UNCRPD, paragraph 1 "States Parties recognize the right of persons with disabilities to an adequate standard of living for themselves and their families, including adequate food, clothing and housing, and to the continuous improvement of living conditions"; paragraph 2, (a) "States Parties shall ensure equal access to appropriate and affordable services, devices and other assistance for disability-related needs"; (b) "To ensure access by persons with disabilities, in particular women and girls with disabilities and older persons with disabilities, to social protection programs and poverty reduction programs". This year's celebration adopts the theme, ***"Kalusugan at Kaunlaran ng Pilipinong May Kapansanan, Isulong sa Gitna ng Pandemya"***.

As a State Party to the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD), the Philippine government recognize the right of persons with disabilities to an adequate standard of living for themselves and their families, including adequate food, clothing and housing, and to the continuous improvement of living conditions, and shall take appropriate steps to safeguard and promote the realization of this right without discrimination on the basis of disability.

OBJECTIVES

General Objective:

To commemorate the 43rd National Disability Prevention and Rehabilitation Program

Specific:

- 1.) To share the regional accomplishment, issues and concerns and recommendations in the implementation of Persons with Disability Program;
- 2.) To promote awareness on the issues and concerns relative to disability;
- 3.) To showcase the talents of persons with disability in singing through the PWD Virtual Singing Contest Year 2021;
- 4.) To recognize individuals, groups and agencies that have made outstanding contributions to persons with disabilities;
- 5.) To promote wider recognition of disabled persons as self-respecting, self-reliant and productive members of society;

Enjoys acceptance and respect from peers with disabilities, advocates and service providers

Nominations will be sent to the Provincial Social Welfare and Development Office (PSWDO) in coordination with the Persons with Disability Affairs Office (PDAO) or RCDA Member Agencies from 29 July 2021 to 6 August 2021, 12 Noon. One PWD per province will be chosen and be given the PWD Bayani Ka Award Year 2021. Each will be given a cash prize of Php 3,000.00.

PARTICIPANTS

The webinar series is open to the public of all ages, particularly to women and girls. Other stakeholders such as government agencies, including representatives of RIACAT-VAWC/RIACACP and RCDA and staff members of DSWD Field Office IV-A, Local Government Units, NGOs, and women's organizations are likewise invited to attend.

Since the event will be held through an online platform, the participants will be coming from a diverse background and experiences. Knowledge on the issues concerning women is varied, ranging from minimal to knowledgeable.

Pre-registration form will open one (1) week before the schedule and will run until 12:00NN of the activity schedule. Meeting access details (meeting ID and password) will be sent to the participants after the acceptance of their pre-registration form.

OPEN FORUM COMPONENT

The primary resource speakers for the educational discussion include staff members from the DSWD Field Office IV-A and representatives from the RIACAT-VAWC/RIACACP and RCDA as well as invited individuals of corresponding specializations from various government agencies, NGOs, women's organizations, and/or academe. The resource speakers will be provided with a copy of the Facilitator's Guide and be requested to develop a discussion guide and/or presentation on the assigned topic.

To supplement their sessions with women and girls' perspectives, and with the aim to strengthen the critical role of women and girls as primary stakeholders, the Open Forum component will be included to highlight their struggles, experiences, and stories.

APPROACH FOR THE RESOURCE SPEAKER

Educational Discussions will be allotted a total of 35 minutes each (inclusive of Open Forum). The resource speaker may use any approach that would most effectively deliver the key messages and meet the objectives of the session. Also, the session is requested to be made engaging as possible as to respond to the limitations of online setting.

The resource speakers shall provide a copy of the module / discussion guide and the PowerPoint presentation and include any materials/ assistance needed for the session. It will be reviewed by the organizers so as to be ready to give assistance or support for the session. Lastly, the webinar series is presented as a casual event, emphasizing an environment that is immersive, enjoyable, and knowledgeable for the participants.

CONSENT TO RECORD AND LIVE-STREAM

Since the event will be held via Zoom and will be live-streamed through Facebook, the whole duration of the activity will be recorded and uploaded automatically in these

platforms. Please be guided that as such, the discussion and the identity of the speakers and those who will appear on the screen will be visible to a wider audience and can be watched at different times.

EVALUATION

At the end of each webinar episode, an online Evaluation Form will be provided for the participants to fill-out to keep track of the participants' feedback of the whole program, as well as, to identify what changes can be made to improve the program for the next webinar episodes. It will include an assessment of the objectives of each session, the overall objectives of the webinar episode, the speakers, the training design, and the logistical arrangements. Feedback from resource speakers, partners, and other relevant stakeholders will also be gathered and included in the documentation.

Documentation of all the episodes conducted during the current quarter will be compiled until the 10th day of the following month. It will be submitted to the Regional Director and the Central Office along with a short Executive Report.

WORKPLAN

The following workplan is only a proposed framework for the conduct of the webinar series. This will be further improved at the Planning Session of concerned staff at the Field Office and representatives from partner government agencies, NGOs, and women's organizations.

The **planning** will bring together concerned staff at the Field Office – LED Secretariat, Women Focal (Sectoral), Social Marketing Unit, and Capacity Building Unit – to finalize the tasks, strategies, workplan, and timeline for its implementation.

Key to the webinar series is the consistent **engagement with the invited individuals of corresponding specialization** from various government agencies, NGOs, women's organizations, and/or academe for the educational discussion component of the webinar series. The LED Secretariat and/or the Women Focal (Sectoral) will be in-charged in securing the commitment of the invited individuals towards the fulfillment of the webinar episode's objectives.

The **webinar episodes**, assisted by the Social Marketing Unit for the promotions, and Zoom and Facebook Live-streaming, will feature different issues and realities being faced by women and girls.
