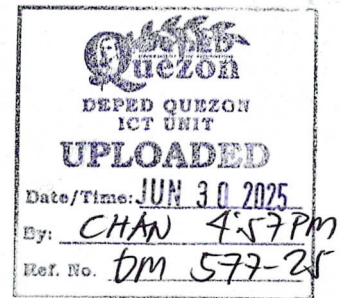

The Department of Social Welfare and Development (DSWD), through the Pantawid Pamilyang Pilipino Program (4Ps), implements the Youth Development Session (YDS) as an educational initiative designed to provide support to high school beneficiaries of the program. YDS aims to empower youth by equipping them with essential knowledge, skills, and values that foster active participation in their learning and personal growth.

For SY 2024-2025, the 4Ps, in collaboration with the Department of Education (DepEd) and various partners, implemented the YDS in 43 high schools in Quezon to further support youth development. Also, to strengthen the collaboration between the Region IV-A offices of DSWD and DepEd, a Memorandum of Agreement for the effective implementation of the 4Ps and YDS was signed in March 2025, with its provisions to form part of the meeting agenda.

To ensure the effectiveness and sustainability of the YDS and plan for a more responsive and impactful implementation for SY 2025-2026, a consultation meeting will be held on **10 July 2025**, at 9:00 AM, in Quezon. The venue will be confirmed in a follow-up communication.
