

- DepEd Order No. 44, s. 2015 requires the preparation of the School Report Card (SRC) and the Project Monitoring Report Form (PMRF) at the end of each school year.
- As stated in the Order, the SRC is a tool for advocating and communicating the school situation, context, and performance to internal and external stakeholders, in order to further strengthen shared governance through increased understanding and stronger participation in making the school a better place to learn.
- On the other hand, the PMRF is used to monitor the progress and accomplishments on school projects after each SY of the three-year cycle.
- 4. In connection with the above mandate, all public elementary and secondary schools are expected to submit a PDF copy of their SRC and PMRF for SY 2021-2022 to the Schools Division Office (SDO) through the School Governance and Operations Division (SGOD) School Management Monitoring and Evaluation (SMME) Section.
- Be advised that only the SRC Summary of Information (Annex 11, SIP Guidebook) shall be forwarded to the SDO. The School Planning Team (SPT) and Project Mangement Teams (PMTs) may add other Performance Indicators based on programs and projects stated in their Enhanced-School Improvement Plan (E-SIP).
