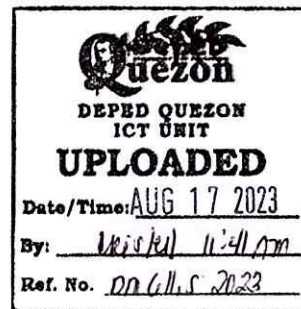

QUICK COUNT ENROLLMENT FACILITY FOR SY 2022-2023

1. In line with the implementation of Learner Information System (LIS) Quick Count (QC) for SY 2022-2023, please be informed that QC Facility is now open for encoding for regular students while QC facility for ALS will be deployed on a later date.
2. It is expected that schools with internet access shall update their enrollment in QC every Friday, while those without access (in hard-to-reach and remote areas) shall update their enrollment on the first and last Fridays that QC is in effect, or as often as is practical.
3. This Division will communicate the Quick Count Enrollment status every week until the facility closes through the SGOD - Planning and Research Section.

Quick Count Facility for School Year 2023-2024 is now open for encoding.

The Quick Count Facility in the Learner Information System enables the Department of Education to monitor enrollment updates in our schools for reporting to the different offices across all governance levels and stakeholders.

Hence, schools are advised to encode their Quick Count Enrollment Data for School Year 2023-2024 in the Learner Information System (LIS) based on the number of enrolled learners. Schools will only encode the total number of learners by grade level and allowed to update the data daily if there are changes.

The Policy, Planning, and Research Division (PPRD) of the Regional Offices (ROs) and School Governance Operations Division-Planning and Research Unit (SGOD-PRU) shall jointly monitor and ensure that schools encode their data in the system. Schools with difficulties in encoding the data shall be given appropriate technical assistance.
