

- 1. The Schools Division of Quezon has been ISO certified since September 9, 2018 until September 4, 2021 but since the Department of Education issued the Department Order No.9, s. 2021 INSTITUTIONALIZATION OF A QUALITY MANAGEMENT SYSTEM IN THE DEPARTMENT OF EDUCATION, it made the Office decide to cease the renewal of ISO certification.
- 2. DepED Quezon's decision not to renew the ISO certification is specifically based on Enclosure to DO 9, s. 2021 titled GUIDELINES ON THE INSTITUTIONALIZATION OF QUALITY MANAGEMENT SYSTEM IN THE DEPARTMENT OF EDUCATION Article IX, 5B that provides: "Recertification of field offices and schools with ISO Certification expiring in 2020 shall be held in abeyance until the issuance of the National Operations Manuals of the Regional Offices, Schools Division Offices..."
- DepED Quezon's desire to sustain the ISO aligned practices in the Division leads this Office to launch "One DepED QMS" on September 2, 2021 at 1:00 - 5:00 pm via zoom at


